## Election of Chairman and Vice Chairman

Cllr Foster proposed Cllr Warwick for the position of Chairman of the Parish Council for the forthcoming year, seconded by Cllr Olley and carried. Cllr Warwick accepted the position and signed the Declaration of Acceptance of Office.

Cllr Warwick proposed Cllr Olley for the position of Vice Chairman of the Parish Council for the forthcoming year, seconded by Cllr Hughes-Wade and carried. Cllr Olley accepted the position.

Welcome and to consider accepting apologies for absence

Cllr Warwick, Chairman of the Parish Council, welcomed those present to the meeting. Apologies for absence were received from Cllr A Jenness and these were accepted.

To declare any Interests re items on the agenda

There were no Interests declared.

To co-opt onto the Parish Council, if possible

Cllr Warwick proposed Mrs Sally Knight be co-opted onto the Parish Council, seconded by Cllr Foster and carried. Cllr Knight then completed the Declaration of Acceptance of Office and the Interest form.

# PUBLIC PARTICIPATION PERIOD

The Consultation period for people to make comments on the Norwich Western Link (Norwich Northern Distributor Road) is from 8<sup>th</sup> May until 3rd July and anyone can comment. Under the Public Health grant, there are going to be 4 mobile phone detector units used and this

project will be trialed for a year.

There was some discussion regarding a field that used to be accessible for dog walking is now not accessible. Cllr Warwick will speak to the dog warden about the situation. If land has stewardship on it, it cannot be used for dog walking.

Cllr Richmond spoke about the housing situation and lack of affordable houses in parishes for siblings wishing to remain in the same vicinity as their parents. He said the new houses in Mileham had proved to be successful and he will try to get the situation improved in other areas.

3PL/2018/0288/HOU and 3PL/2018/0289/LB Mr & Mrs A Jenness, Manor Farm, Manor Drift, demolition of existing rear 1  $\frac{1}{2}$  storey extension and construction of new 2 storey rear extension. The Parish Council had no comment to make on this application.

At Grange Road there are some bad pot holes and the water coming off the field is not being controlled. The Highways Department will be asked to make this a matter of urgency. The Highways Rangers have not visited the parish for a while and verge grass cutting has not been carried out yet. Highways will be chased up on this. The proprietor of Dereham Firewood Supplies has carried out some very good work on the land and there are cows in the field.
