MINUTES OF THE ANNUAL PARISH COUNCIL MEETING HELD IN THE WENDLING VILLAGE HALL ON THURSDAY 18TH MAY 2023 AT 8.00 P.M.

Cllr Knight proposed Cllr Warwick, seconded by Cllr Foster. Cllr Warwick accepted the position. The Clerk received the signed Declaration of Acceptance of Office form.

To co-opt onto the Parish Council Mr David Kemble and for Clerk to receive the signed Declaration of Acceptance of Office.

- Welcome and to consider accepting apologies for absence. Cllr Warwick welcomed those present to the meeting. Apologies for absence were received from Mr Kemble and Dist. Cllr Atterwill.
- To declare any Interests re items on the agenda. 5. No interests were declared.

Cllr Foster spoke of concerns regarding car drivers coming down Station Road and not realising the entrance to the Wendling Methodist Church was close by. She wondered whether a sign stating 'Concealed Entrance' could be sited. Cllr Kiddle-Morris offered to find out if Norfolk County Council would put up a sign. Regulations will need to be investigated. The reason for the sign is to try to prevent an accident happening when the mothers and toddlers are leaving the Methodist Church and coming out of the car park. Drivers drive very fast around the corner from Swaffham Road into Station Road. Cllr Warwick will also look into this problem.

Cllr Richard Duffield was congratulated on being re-elected. He said Breckland Council had done a great deal of work over the last year.



The Leader of Norfolk County Council has changed as the previous Leader is ill. The new Leader is Cllr Kay Mason-Billig. She has a different style of Leadership. There will be more Deputy Cabinet Leaders. It will be a new era for the next 2 years. The devolution is still be discussed and the consultation that went out has come back and is now being discussed.

The Parish Council meets the eligibility criteria for readopting the General Power of Competence as defined in the Localism Act 2011 and S1 965 The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012. All the Parish Councillors have been elected and they have a Qualified Clerk, one with the CiLCA qualification. The Parish Council voted to adopt this Power. The General Power of Competence gives a local authority the power to do anything which individuals generally may do. It is a power of first resort, rather than an older power.

17. To discuss the success of the Village Litter Pick and Easter Egg Hunt.
